Government Relations Update

June-July 2021

Federal

- July 1, 2021 – USDOT/FAA announced \$845 M in infrastructure grants (FY2021 AIP), inc. \$100 M in ARA Act funding to award funding at a 100% federal share.
- June 22, 2021 – USDOT/FAA announced the allocations of \$8 billion in American Rescue Act grant funding. Non-primary commercial service and general aviation airports share \$100 million in funding based upon airport category. NFRA is eligible to receive \$22,000.

State

- Governor DeSantis finalized his review and approval process for 2021 bills.

Runway 13-31 was closed temporarily following the accident to facilitate NTSB/FAA inspection of the crash site and emergency pavement rehabilitation.
