I hope your morning is going well!

Attached is a memo discussing how the FAA's December 13, 2019 comments on the SGJ ALP were addressed. I have also provided a history of correspondence between Passero, the FAA and FDOT regarding the draft Master Plan and ALP submittals.

### FAA

- June 20, 2019: Passero FedEx Package containing full draft of Master Plan to Stephen Wilson of the FAA. Additionally, a 24" x 36" ALP set sent out via FedEx to Stephen Wilson on June 24, 2019.
- June 24, 2019: Stephen acknowledges receipt of FedEx package.
- July 3, 2019: Stephen Wilson followed up and asked if an ALP checklist was submitted as well.
  - o July 3, 2019: Passero stated that a checklist was not submitted with this deliverable, but one would be submitted when the ALP is finalized. Stephen then asked if the document and drawing was a preliminary submittal. Passero stated that it was a preliminary submittal. Stephen then said that the official review cannot begin until a checklist was submitted.
- July 24, 2019: After internal review of the June 24, 2019 ALP submittal, it was agreed that the ALP was ready for FAA review. An FAA ARP SOP 2.00 and 3.00 Checklist was sent to Stephen Wilson on July 24, 2019.
- July 25, 2019: Stephen Wilson acknowledged receipt of the checklists via email.
- August 21, 2019: Stephen emailed the Sponsor and Passero and stated the following: "Does
  the airport intend to coordinate the Draft ALP with the Proposed/Future 13R/31L Runway? If
  so, we will need to delete the Proposed/Runway 5/23 depicted on the old ALP from our
  database."
  - o Passero responded, on behalf of the Sponsor, that the Airport wants to move forward with the 13R/31L Runway, and not the proposed Runway 5/23 which was proposed

in the previous Master Plan study.

- August 22, 2019: Stephen Wilson emailed the Sponsor and Passero with the following question: "What is the intended use of the Proposed Multi-Use Development Area shown on the ALP in Blue?".
  - o Passero's response, on behalf of the Sponsor: "The blue area is a proposed flexible use site that could be used for aeronautical/non-aeronautical development that would be a revenue-producer for the airport."
- August 23, 2019: Stephen Wilson emailed Passero stating that we need to "reconvene" on the ALP. This email included several bullet points with comments ranging from ALP drawing scale edits to make text more legible, to the need for justifying the crossing of Taxiway A over U.S. 1.
  - o Follow-up call between Passero and Stephen to discuss comments further. Passero discussed the comments further internally, then started addressing the FAA comments on the drawings and responding to Stephen's comments with a memo.
- **August 29, 2019:** Passero submitted a memo to Stephen Wilson stating responses on how each comment will be addressed, and providing answers to questions.
- **September 11, 2019:** Stephen Wilson emailed Passero and Sponsor asking for a re-submission of the Draft ALP, with the changes noted in his August 23, 2019 email. He also stated that once the FAA fully reviews the Draft ALP, it will be coordinated in OE/AAA.
- **September 25, 2019:** Passero worked internally to update the draft ALP, and shipped the updated ALP and FAA checklists to the FAA via FedEx on September 25, 2019.
- October 1, 2019: Stephen Wilson confirmed that he received the ALP and checklists.
- October 28, 2019: On behalf of the Sponsor, Passero reached out to Stephen Wilson asking for a status update on the ALP review. Stephen Wilson responded: "We hope to wrap up our review this week."
- **November 21, 2019:** Stephen Wilson emailed the Sponsor and Passero stating that the FAA had additional comments. He also recommended meeting about the comments in person and combine the meeting with the NFRA ACIP meeting.
  - o November 22, 2019: Passero emailed Stephen Wilson to let him know that the Sponsor was updated on the status of the ALP, and that the Sponsor would not want to wait to discuss the comments.
- **November 25, 2019:** Stephen Wilson sent the Sponsor and Passero an email stating that the comments would be compiled and submitted as soon as possible.
- **December 13, 2019:** Stephen Wilson sent the Sponsor and Passero an email including FAA comments on the September 25, 2019 ALP.
  - Passero is working internally and with the Sponsor to address comments via memo (attached).

**August 1, 2019:** Passero submits the draft Master Plan, draft ALP and FAA checklists via FDOT's ftp portal to Nick Harwell. This is the same document that was sent to the FAA on July 24, 2019.

**August 5, 2019:** Nick Harwell forwarded the draft Master and ALP internally within FDOT, and Abdul Hatim confirmed receipt of the documents, but asked that the documents be uploaded into the JACIP for his review.

**August 13, 2019:** Barbara Cloud stated that the files were uploaded into the JACIP successfully for his review.

**September 16, 2019:** Barbara Cloud emailed the Sponsor reminding them that the FDOT grant was going to expire on September 30, 2019. Barbara asks the Sponsor if they want a time extension on the project.
