### **Chief Financial Officer Job Description**

The Chief Financial Officer will be responsible for providing leadership and advice to the Executive Director and the Board of Directors to ensure the financial health of the Authority, guiding the efficient utilization of resources, and contributing to the strategic direction of the airport.

The CFO will work closely with the Executive Director, the Board of Directors, and key stakeholders to develop financial strategies, manage budgets, and provide financial leadership.

Duties include:

- Develop and execute financial strategies to support the Airport's mission and goals.
- Oversee financial planning, budgeting, forecasting, cost of service analyses, and audit preparation.
- Manage financial reporting, ensuring accuracy and compliance with relevant regulations.
- Oversee accounting system, administrative policies, procedures, workflows, and electronic and physical filing systems.
- Manage vendor contracts and relationships.
- Administer FAA and FLDOT grants.
- Lead financial risk management and asset management efforts.
- Evaluate investment opportunities with the Authority's Financial Advisor and recommend strategies for financial growth.
- Collaborate with internal and external stakeholders on financial matters.
- Supervise a dedicated finance and procurement team, fostering professional growth and development.

### Qualifications:

Bachelor's degree in finance, accounting, or related field (MBA/CPA/CMA preferred).

- Proven experience as a financial executive, preferably in the aviation industry.
- Strong financial and strategic planning skills.
- Excellent leadership, communication, and interpersonal abilities.
- Proficiency in financial software and tools.
- Knowledge of relevant industry regulations and best practices.

### Airport Facility Manager Job Description

Under administrative direction, is responsible for the management of the Airport Facilities Division, including facility asset management, budgeting resources, building conversions and maintenance, HVAC, and warehouse oversight. Working conditions are primarily inside an office environment. Exercises direct supervision over assigned staff.

This position is an "unclassified" position and has no disciplinary appeal rights to the Municipal Civil Service Commission. This position is likewise subject to at-will employment status and can be terminated at any time for any reason.

Duties include:

- Manages the implementation of new technological systems.
- Formulates and manages the operational performance, sets operational and financial goals, and assists in the development of the budget.
- Manages the implementation and oversees the operation of quality controls and service delivery plans associated with building operations.
- Manages the implementation and operation of an inventory control system.
- Negotiates contracts with vendors and service providers.
- Manages the implementation and operation of a work order tracking system.
- Manages the implementation and oversees the operation of quality controls associated with building maintenance and asset management.
- Oversees building construction projects to ensure delivery on time, within a preestablished budget, and of superior quality.
- Manages the implementation and operation of a building preventive maintenance program.
- Performs related duties and fulfills responsibilities as required.

Qualifications:

- Bachelor's Degree from an accredited college or university.
- Six (6} years of experience in the management of public or private facilities, including two (2) years of supervisory responsibility.
