25 to install for our upcoming year. So, with that,

2 I'm sure, Mr. Brunson, you've attended many
3 of the meetings, so you know what the positions
4 entail, and obviously this board does, too.

5 Mr. Gorman? I'm sorry.

6 MR. GORMAN: Yes, I'd like to point out the
7 fact -- I wanted to make sure of the fact that if
8 someone on the board accepts a nomination, they in
9 fact are voting for themselves. Two other votes
10 will suffice for a majority, correct? Correct.
11 Object.

12 CHAIRMAN GREEN: I'm not sure. I'll refer to
13 Doug. But just because one's nominated doesn't

14 mean they accept.

15 MR. GORMAN: Yes. In other words, if you
16 nominate someone, they are then voting for
17 themselves. Two other votes on the board will
18 then suffice for a majority.

19 MR. BURNETT: If someone's nominating
20 themselves -- himself --

21 MR. GORMAN: If I nominate someone, they're
22 voting for themselves. I mean, it's just a moot
23 point to me, but I am making this clear --

24 MR. BURNETT: If I'm not --

25 MR. GORMAN: -- to myself, the new members,

2 MR. BURNETT: Someone may not actually vote
3 for themselves.

4 CHAIRMAN GREEN: Correct.

5 MR. BURNETT: And I -- and I believe I've
6 seen that happen at the County.

7 MR. GORMAN: No. Then I would disagree with
8 you.

9 MR. BURNETT: I believe I've seen it happen
10 at the County Commission.

11 MR. GORMAN: I don't argue with lawyers. I
12 just disagree with you, because I checked.

13 MR. COX: But what if the other person did
14 vote for the other -- somebody else, Jack? I
15 mean, if you were nominated --

16 MR. GORMAN: Let's say --

17 MR. COX: -- and you voted for --

18 MR. GORMAN: Let's say that you nominate
19 someone, okay, and then two other board members --
20 then one seconds that, and then another -- and the
21 vote comes down, and it's -- and the one does not
22 have to vote; they've already voted for
23 themselves. And two other people vote for. That
24 means that's a majority. No, really, Bob, it's
25 simple.

1 CHAIRMAN GREEN: I think everyone's vote
2 needs to be registered out loud as to who they're
3 voting for and not.

4 MR. GORMAN: Well, that's fine. They'd have
5 to vote for themselves.

6 CHAIRMAN GREEN: I don't think any --

7 MR. GORMAN: That's what I'm telling them, to
8 vote for themselves, then.

9 CHAIRMAN GREEN: I'm -- I'm just saying, I
10 don't think anything's presumed.

11 MR. GORMAN: That's fine.

12 MR. BURNETT: You -- you may not have someone
13 vote for themselves, though.

14 MR. GORMAN: I disagree. In other words, by
15 them -- by them accepting the nomination, they are
16 actually voting for themselves. And then I have
17 checked with this before with someone that was in
18 the legislature --

19 MR. BURNETT: Oh, I see. I see.

20 MR. GORMAN: -- and they're an attorney, and
21 that's what they told me.

22 MR. GEORGE: But he's not our attorney.

23 MR. GORMAN: I believe that if you're
24 nominated, you are voting for yourself. I'd like
25 that to be something that is understood. And if

1 they have to say --

2 MR. BRUNSON: If you accept the nomination.

3 MR. GORMAN: -- aye for themselves, fine.

4 Yes.

5 MR. BRUNSON: If you accept the nomination,
6 then, sure, you --

7 MR. GORMAN: Correct.

8 MR. BRUNSON: But you still --

9 MR. GORMAN: It's just a point I'm trying to
10 make very clear.

11 MR. BRUNSON: Still going to vote.

12 CHAIRMAN GREEN: Doug, I'm going to defer to
13 you. But I -- I just can't see if someone is
14 nominated --

15 MR. WUELLNER: Statutory requirement to vote.

16 MR. BURNETT: It's no different than -- it's

17 no different than a normal motion, and so if

18 there's five board members here, and the majority

19 would be three voting members, you're -- you're

20 still going to have the majority vote, three --

21 three votes for whatever that action is. And it

22 would be no different than if it was any other

23 board action.

24 MR. GORMAN: Again, again, if you're a board

25 member -- if you're someone I want to nominate, if

1 I nominate you, fine. Then you accept the

2 nomination. Then two other people on the board

3 have to vote for you, and then that would be a

4 majority.

5 MR. COX: By default, you have --

6 MR. GORMAN: By default, you have, yes.

7 MR. COX: -- voted for yourself by accepting

8 the nomination --

9 MR. GORMAN: Right.

10 MR. COX: -- because you -- you know what I'm
11 saying? I understand what he's saying; I just --

12 MR. BURNETT: You may have different board
13 rules. Each -- and -- and it may be specific to
14 each board. I don't believe the airport has
15 specific rules -- and I've got them here. I don't
16 believe the airport has a specific rule addressing
17 the issue you have.

18 It may that other government bodies, maybe
19 even the legislature or some other subcommittee of
20 the legislature or some other body that has that
21 type of rule and process.

22 MR. GORMAN: And in this -- and in this
23 instance, I'm saying that that would be a legal
24 and binding vote for the person that is nominated
25 that accepts the nomination. They just say aye

1 for themselves, if that's what you want to do.

2 MR. GEORGE: I have a hypothetical situation.

3 MR. GORMAN: All right.

4 MR. GEORGE: Individual A is nominated and he
5 accepts, you know, the nomination.

6 MR. GORMAN: Correct.

7 MR. GEORGE: Somebody else nominates C, and A
8 says, "Well, C would be better for the job." By
9 the way we do it, he gets an opportunity to vote
10 for C and not vote for himself. You're saying
11 vote before you find out who else is running.

12 MR. GORMAN: You should be a lawyer. You're
13 obscuring the issue. No. What I'm --

14 MR. GEORGE: Your way -- your way is
15 limiting --

16 MR. GORMAN: -- I'm saying is -- we're
17 going -- right.

18 MR. GEORGE: -- and the -- and the way we
19 have done it in the past, and the other way gives
20 them the option.

21 MR. GORMAN: It's --

22 MR. GEORGE: I mean, the option's in the --
23 in the individual's hand.

24 MR. GORMAN: I'm just -- I'm just saying what
25 is legal under the State of Florida.

1 MR. GEORGE: Oh.

2 MR. GORMAN: I what understand what you're
3 saying, Buzz.

4 CHAIRMAN GREEN: Well, I think we need to
5 operate under the rules this board has been
6 operating under for however many years, that
7 there's a nomination, and everybody votes, no
8 presumption of whom anybody's voting for, whether
9 you accept nominations or not. It probably is a
10 moot point.

11 MR. GORMAN: If -- if we get to that point
12 and -- and the election fails, I would contest it.

13 CHAIRMAN GREEN: I guess you're entitled to
14 do whatever --

15 MR. GORMAN: Okay.

16 CHAIRMAN GREEN: -- you feel as a board
17 member, but it may be a moot point; I don't know.
18 But I think everyone's entitled to a vote, out
19 loud and on the record, as to who they would like
20 to vote for, with no presumptions included.

21 MR. GORMAN: And I'm just saying that the
22 nominee then needs to vote for themselves so there
23 will not be any presumptions.

24 CHAIRMAN GREEN: Okay. I'll entertain
25 nominations for -- we can start with chairman.

1 MR. BRUNSON: I'd like to nominate -- first
2 by nominating, I want to first say that the
3 present chair and treasurer, I think, has done an
4 unbelievable job and -- and in the many meetings
5 I've been. But I'd like to nominate Jack Gorman
6 for treasurer.

7 MR. WUELLNER: Wait. Okay.

8 CHAIRMAN GREEN: We're just making

9 nominations. What, Mr. Wuellner?

10 MR. WUELLNER: I just want to make -- he's

11 nominating for treasurer.

12 CHAIRMAN GREEN: This is for -- this is

13 chairman.

14 MR. BRUNSON: Oh, for chair -- you go

15 chairman first.

16 CHAIRMAN GREEN: I started with chairman. It

17 didn't --

18 MR. BRUNSON: Okay. I'm sorry.

8 Cox for chairman of the board. I have a little
9 statement. Quick. After two years, he's
10 well-seasoned, he's shown a reserved and
11 analytical quality. And as a board, we should
12 entertain different perspectives, first that of a
13 lawyer and now that of an individual employed in
14 aviation. He'd be an excellent choice. That's my
15 nomination.

16 MR. COX: I appreciate that. And based on

21 4. - APPROVAL OF MINUTES

22 CHAIRMAN GREEN: Approval of the minutes. We

23 have our minutes from our last meeting. And has
24 everyone had a chance to go through it? Are there
25 any exceptions to those minutes?

2 CHAIRMAN GREEN: Hearing no exceptions or
3 deletions or additions, the meetings (sic) will be
4 approved as presented.

5 5. - ACCEPTANCE OF FINANCIAL REPORTS

6 CHAIRMAN GREEN: Next, we have our financial
7 reports. Mr. George?

8 MR. GEORGE: Madam Chairman, this is the
9 report ending December the 31st. And this came
10 back from the -- from the CPA this -- this week.
11 Usually when I look at these, I -- my first
12 statement, the month of December's transactions
13 have been reviewed from the checkbook standpoint,
14 and they look, you know, to be in order to me.
15 The financial statements -- and Donna's not

16 here and I have not had a chance to go over it
17 with her, but if we start looking at the
18 year-to-date budget, you know, versus the
19 year-to-date actuals, we -- we see signs that
20 we've got some trouble. You know, that we're --
21 that we're going to be running over the budget.

22 We've got the -- the insurance, if I'm not
23 mistaken, was what, \$25,000 more than we had in
24 the budget; is that correct, Ed? Was it \$25- or
25 \$30-?

1 MR. COX: Insurance for what?

2 MR. WUELLNER: That's a really good question.

3 MR. GEORGE: Ed, liability insurance on all
4 the buildings and everything like that.

5 MR. COX: What page are you on?

6 MR. GEORGE: Down on page 5, if you look like
7 halfway down, insurance and liability, you look at
8 39 percent, you know, variance. You know, if we

9 don't watch the variances, you know, on this, when
10 we get to the end of the year, we will -- in
11 effect, we'll be taking more money out of the tax
12 pool, if you will, to run operations. So, we need
13 to watch that, you know, closely.

14 This report needs to have some other numbers
15 added to it. It does not have monthly numbers for
16 depreciation yet, which froze your grand totals.
17 Looked like we're at 202 percent off, but
18 that's -- that's an easy thing just to come back
19 and take a look at. I will get with Donna and --
20 and go over that. And I urge you guys to look at
21 it in -- in that light. But -- but the numbers
22 for the current month, you know, are correct.

23 CHAIRMAN GREEN: Ed, when we went through the
24 budget, I know you had addressed that issue of
25 insurance. In fact, you even revised it. Did

1 they come up -- did the insurance companies now

2 come up with different figures since the revision?

3 MR. WUELLNER: I'm not aware. I don't recall
4 conversation where we increased the budget over
5 what it was. That may have been the timing of
6 the -- of the quote, or the -- the binder --

7 MR. GEORGE: I think there was another --

8 MR. WUELLNER: -- whatever it is, is right
9 after the fiscal year.

10 MR. GEORGE: -- item that we had -- we had
11 increased, which cut into the amount of surplus
12 that was going back to -- into that. But what I'm
13 saying is, if we don't start looking, you know, at
14 some of these, we'll see that they're going over
15 and -- and need to pay attention to them.

16 Some of the items, you'll see that the budget
17 item, for instance, top of page 3, accounting and
18 auditing, year-to-date actuals, \$18,200. But the
19 year-to-date budget is \$5,500. That's because our
20 audit at the end of the year, the price, the
21 invoice for that came and it was paid.

22 But the accountants have said this is
23 something you accrue every month as a -- as an

24 expense. So, this will correct itself by the time
25 it gets to the end of the year. And it's just

1 that, as you're going through them, you just need
2 to know which ones will correct and -- and so
3 forth.

4 But hopefully, we'll be able to look at
5 operating revenues versus operating expenses. And

8 to it more than just once a year.

9 CHAIRMAN GREEN: Okay. Any other comments on
10 the financial statements for the year ending -- or
11 three months ending December 31, 2004?

1 We have, and then we'll -- I'll leave a copy,

2 and they can make copies and distribute them

3 around for the discussion later on. Denise has
4 put together a projected -- a new plan for incomes
5 and revenues to the MPO, and in doing so, where
6 they've tried to reevaluate the capability of the
7 different authorities to handle their fair share
8 of an MPO expense.

9 And in short, what she's come up with -- in
10 the old system that we approved originally was
11 each of the authorities had to pay a 5 percent
12 charge. And that came out to the \$13,000.

13 What she is prepared now and going to
14 recommend for next year, is that we go with a 5
15 percent of the County's responsibility. So, in
16 your particular case, if we left it -- the County
17 pays right now 25 -- 25 cents? Twenty-five cents
18 per capita of those people inside the MPO. And
19 that changes every year, based upon per capita
20 projections. Currently, you pay \$13,200.

21 Under the next year's budget, you're at the
22 same rate of 25 cents per capita, your fair share
23 being 5 percent of our total would be \$1,759 --

24 MR. GEORGE: Okay.

25 COMMISSIONER MAGUIRE: -- okay? And if we go

1 to 30 cents, because as revenues -- if we drop off
2 your revenues and we have to elevate them at the
3 county level, so we may have to raise it to 30
4 cents, and then your cost will go up to \$2,100.

5 But it would be based on -- if we can get the
6 board to accept this, it would be based on 5
7 percent of the County's responsibility, not 5
8 percent of another figure.

9 Referencing this year's -- Randy called me up
10 the other night and asked me some questions
11 referencing this year's budget. If you find that
12 you cannot justify \$13,200, my request to you is,
13 come up with a figure you can justify, and then we
14 can take it back to the MPO board and see if they
15 will accept it. And I can't give you any guidance
16 on that. Just what you feel you can justify for
17 this year.

18 And then in saying that, the other boards,
19 obviously bigger than -- and larger and more
20 capable, they did pay the full 5 percent, except
21 for the Nassau Port Authority, and they only paid
22 about \$500, but we removed their voting
23 privileges.

24 So, they will be able to come back on next
25 year at -- at the new rate and be coming back on

9 budget, I think, is what, less than a million
10 dollars? And they live on a very nominal budget,

11 anyway. So -- so, come up with something you can

13 board. And then Denise will answer any questions
14 later on.

15 CHAIRMAN GREEN: Mr. Cox?

16 MR. COX: What do you think would be
17 justifiable? I mean --

7 want to bring the board up to date on the Super
8 Bowl issues that are happening. We're now 18 days
9 away from Super Bowl, and we're all starting to
10 get a little -- a little panicked.

11 The airport will be the host to many of the
12 prominent participants and sponsors of the Super
13 Bowl. Aero Sport's prepared. We're putting on
14 extra staff from February 2nd to the 7th. We'll

7 MR. COX: Forty-five?

8 MR. SLINGLUFF: Forty-five. Cecil is taking
9 85 airplanes. They already have 85 large jet
10 reservations. They have virtually no ground

11 transportation. It's fallen through the cracks.

14 And we also heard yesterday that the

2 mediation is still open. It was not closed at
3 that time. Terry White's the mediator. He's a

22 MR. KNIGHT: Oh, in traffic count. Okay.

23 The control tower receives a count for every
24 aircraft that lands or does a low approach if a --
25 as an arrival, and also one count as a departure.

1 There's only one exception, and that exception is
2 the -- let's say an IFR aircraft or an instrument,
3 aircraft on an instrument flight plan, we only

7 a third subject, we expect that to be operational
8 Monday, completely.

9 MR. WUELLNER: With your filter?

7 through FAA to get into here?

2 8. - PROJECT UPDATES

3 MR. WUELLNER: The project updates. You'll
4 notice a few projects conspicuously absent because
5 they have, for the most part, been completed, as
6 we mentioned last month.

7 Land acquisition, Araquay Park; terminal
8 parking lot; south development area apron design;
9 the eastside corporate hangars 8, 9, and 10;
10 second floor buildout; home demolition update;
11 runway 2/20. Well, turning that into a full-time
12 runway status. Marketing and public relations;
13 and airport leasing activities, as well as I'll

14 let you decide whether you get another briefing on
15 the Master Plan or not.

16 Land acquisition, Araquay Park. As we've
17 already heard from our attorneys, we're
18 negotiating still with several owners in -- in
19 advance of the February 1st hearing date. And, of
20 course, hearing is set for February 1st at 1:30 at
21 this point. That, for the most part, brings you
22 up to speed.

23 I think we mentioned last month that we had
24 come to a contract settlement with one -- one of
25 them, and another one has apparently negotiated

AIRPORT AUTHORITY REGULAR MEETING - JANUARY 19, 2005

49

1 that settlement. However, for cleanliness of the
2 transaction, as it was described to me, they'll go
3 ahead and go through a voluntary -- actually two
4 of them will go through effectively a voluntary
5 condemnation process for purposes of title. So,
6 you've got three of them that are pretty

7 well-established at this point.

8 Next item is terminal parking lot. The small
9 area paving, that is the areas where we're
10 bringing it from landscaping to paving and/or
11 adding areas into the parking lot, that -- the
12 paving aspect has been completed at this point, to
13 include the north section of that lot, which I
14 think was previously -- you may remember, is areas
15 D and E on the old parking layout plans. That's
16 been completed.

17 We have re -- completed the reconfiguration
18 of that north lot, including the Grip-Flex coating
19 and remarking and landscaping in that north lot,
20 which provided the most net return on new spaces
21 up there, has been completed and is opened.

22 And they'll -- I believe over this weekend,
23 will do a significant portion of the access road
24 and areas back toward the fuel farm over the
25 weekend, which will facilitate some other -- or

1 being able to complete this thing hopefully in the
2 next two weeks to ten days, ten days, two weeks.

3 The Grip-Flex application has been ongoing in
4 various areas as weather permits. There's some
5 temperature issues, as well as moisture issues, so
6 as they can get out there and get it done, they've
7 been doing that, and including the apron area and
8 all associated with the FBO and terminal.

9 And, obviously, we're remarking the pavements
10 as quick as we can get them -- get them dried from
11 the Grip-Flex application. And those of you that
12 have been in the T-hangar area, I think you'll --
13 you can -- you can appreciate the -- the job
14 that's been done there and the new high-contrast
15 yellow markings with the coating that's been
16 applied. And in general, it's a pretty good
17 stopgap -- stopgap effort there in lieu of
18 repainting and adding unnecessarily -- unnecessary
19 weightbearing capability in between T-hangars at
20 this point.

21 All right. Apron south -- south apron
22 design. Preliminary engineering work's ongoing
23 right now, including geotechnical work. The
24 initial survey development, including the tree
25 survey, is ongoing at this point. And while I

1 expect, based on my briefing from the engineering,
2 we'll be seeing some initial concepts for layout
3 of that project so we can bring them to you at
4 next month's meeting. They're not done yet.
5 They're still waiting on the balance of the
6 survey-related data. But I'm sure we'll have some
7 concepts to look at by the next meeting. And then
8 bar -- or assuming some -- some group decision at
9 that meeting, we'll release it for full design
10 and -- of whichever concept you prefer.
11 And home demolition update, just bring you --
12 a fourth batch of homes was offered for -- for
13 public sale. Results are a little later on the

14 agenda, but basically there were eight homes, if
15 my memory's correct, and we have received bids for
16 five of those eight homes. So, we have -- have a
17 decision item in the -- in our -- another agenda
18 item.

19 And otherwise, demolition continues on homes
20 not previously awarded. And I think that's
21 progressing nicely, and I think those that have
22 been awarded for demolition, those -- all of that
23 cleanup and site cleanup should be done within the
24 next ten days.

25 We have a number of homes, as you -- as you

1 probably have surmised from the previous awards of
2 those buildings, that over the next, I would tell
3 you 60 to 90 days, you're going to see a lot of

7 MR. GEORGE: Any way they can start their
8 demolition after 9 o'clock in the morning?

9 MR. WUELLNER: Demolition?

10 MR. GEORGE: There's some -- there's a lot of
11 noise going on back in the -- in the area.

12 MR. WUELLNER: We can certainly ask them to.

13 MR. GEORGE: Disturbing the grapefruit.

14 MR. WUELLNER: We can certainly ask them to.

14 with the airport from a staff standpoint or Aero
15 Sport standpoint will be, I'm sure, pulling long
16 hours over that -- that three- or four-day period.
17 We expect some -- some interesting numbers to
18 develop as a result of that.

19 Also, just point out the Fuji Airship, you
20 may have seen that flying around. I think it
21 departed yesterday, if not --

22 MR. KNIGHT: Leaves tomorrow.

23 MR. WUELLNER: Leaves tomorrow. I guess it's

24 been delayed another day. They've been around for

25 two weeks -- better than two weeks now, and their

2 off the coast. So, that's why they're here. And,

3 MR. WUELLNER: It was -- it was changed

4 administratively by the County approximately that

8 MS. WILLIS: And did that mean then that

9 residential property owners had no notification or

10 rights?

11 MR. WUELLNER: It doesn't change your zoning.

12 It only changed zoning of property actually owned

13 as of March of last year by the Airport Authority.

14 It changed it from whatever its designation was

15 prior to that to Airport. It did not change any
16 private citizens' zoning.

17 MR. BURNETT: And if I might also...

18 MR. WUELLNER: If we did not own the
19 property, it did not change.

20 MS. WILLIS: So, that still has not changed?

21 MR. BURNETT: Let me -- let me add one thing
22 from a technical standpoint. The zoning that
23 you're referring to, Ms. Willis, would be a matter
24 of the Board of County Commissioners, who act on
25 behalf of the government of St. Johns County. And

1 the County Commission would be responsible for
2 properly advertising and noticing that meeting and
3 whatever action they took.

4 MS. WILLIS: Yes, I realize that.

8 I criticized it not being on the agenda.

9 MR. WUELLNER: It's actually a -- I would
10 call it a very old item. It was probably five

14 the Land Development Regulations back -- I want to
15 say it was '99, but plus or minus a little bit of

25 No one's private property that they own was

7 in one fell swoop and changed it from the many,
8 many, many types of zoning of ownership that the
9 Authority had, which was everything from Open
10 Rural to Silviculture to Residential to Commercial
11 to Industrial. We had parcels of all types.

12 All of those designations changed to a single
13 zoning classification that was -- that was
14 developed as a part of the LDRs. And -- and it's
15 now designated as Airport zoning. It's now zoned
16 Airport --

17 CHAIRMAN GREEN: There was a new designation.

18 MR. WUELLNER: -- which is a new
19 classification.

20 MS. WILLIS: What is -- you said it is now
21 zoned. What is?

22 MR. WUELLNER: Anything the Authority owned.

23 MS. WILLIS: Owns. So, that does not include
24 the ones that are still in private ownership.

25 MR. WUELLNER: That is absolutely correct.

18 did 5 percent of the County's share. And I
19 thought it looked pretty reasonable, and that's
20 what I'm going to suggest to them that we do in --
21 in the new fiscal year. This is only our -- this
22 is only our first year so, you know, it's not
23 inappropriate to make a change like that. That's

24 what I'm going to propose that we do for next
25 year.

14 preference, we contacted our engineer about coming
15 up with a satisfactory layout and design for --
16 for corporate hangars to go over in the eastside
17 area in lieu of the four -- if you remember the
18 four-unit existing building that was proposed by
19 Staff.

20 That resulted in a maximum density of being
21 able to create three units over there, or three --
22 well, arbitrary -- I say arbitrarily, but
23 sequentially numbering units, 8, 9, and 10 on the
24 eastside.

25 Engineering design proposal from Passero is

1 attached as a part of your agenda item. I
2 apologize for the lateness of it, but it was
3 undergoing significant revision from the first --
4 first blush on it.

5 We have upgraded from two units to three
6 units in order to achieve maximum density on that
7 property. The unit size is approximately 7,200
8 square foot per unit. Includes some minimal
9 office. To give you a perspective, that's the
10 approximate size, within about ten square foot, of
11 what the original Sheriff's hangar facility was
12 over on the eastside corporate area.

13 So, there are three units of that size in one
14 building. It would result in a little over 21,000
15 square foot of total facility. Initial
16 calculations have determined that the ROI would
17 certainly be within acceptable -- or within lease
18 policy guidelines, once leases are actually
19 determined.

20 Initial construction value's estimated at
21 approximately \$900,000. My apology for not
22 advancing that -- twice. And if the project were
23 to be begun about now, we would anticipate
24 somewhere toward -- at the end of the year would
25 be approximate occupancy when you factor design,

1 permitting, and actual construction time into the
2 mix. And it typically is about a one-year
3 process.

12 you want to make a decision to go that way, they

13 can work it into the plans. You're still, what,

14 60 to 90 days from bidding it, so...

15 MR. GORMAN: Question, too: This is the

16 redrawn --

17 MR. WUELLNER: Yes.

18 MR. GORMAN: You and I talked about in

19 initial. And this is the redrawn to maximize the

20 square footage.

21 MR. WUELLNER: Exactly.

22 MR. GORMAN: And these would be in lieu of

23 the four that --

24 MR. WUELLNER: It would be in lieu of the

25 four original, and it would be in lieu of the

1 first version with just two hangars. This is

2 maximum square footage.

3 MR. GORMAN: So, in other words, if we are

4 going to redraw, this is the maximum that you can

5 possibly throw in the pile.

6 MR. WUELLNER: Yeah, and get parking and the

7 like in there, yes.

8 MR. GORMAN: I know that we were looking at

9 four.

10 CHAIRMAN GREEN: Mr. Cox?

11 MR. COX: Did we lose any square footage

12 availability by going to three as opposed to four?

13 MR. WUELLNER: Actually, we picked up about

14 5-, 6,000 square foot in total.

15 MR. COX: The -- the area between the -- the

16 southwest corner there down to the Sheriff's

17 hangar, what -- what's all that space?

18 MR. WUELLNER: That space is --

19 MR. COX: Not usable?

20 MR. WUELLNER: -- required for fire code

21 separation.

22 MR. COX: Okay. All right.

23 MR. WUELLNER: Under NFP 409, I believe it

24 is, you've got to get a 75-foot buffer between the

25 buildings. It's to --

1 MR. GEORGE: We went from four hangars at

2 4,000 apiece for a total of 16-, to three at

3 7,000, a total of 21-. So, you picked up another

4 5,000.

5 MR. COX: All right.

6 MR. WUELLNER: And cut your construction
7 costs likely, too, because you're -- you're
8 sharing a common building structure. You're
9 separating -- you've got -- you know, versus
10 stand-alone buildings.

11 MR. GORMAN: Of course, that is my question,
12 then. I'm rehashing old ground now, because I got
13 outvoted -- Bob and I voted for the four, and then
14 I got outvoted to vote -- to go for the two large
15 ones. But have we -- have we studied and stuck
16 with the amortization of the new buildings versus
17 using our old materials? I mean, is this --

18 MR. WUELLNER: Yes. This would be entirely
19 new.

20 MR. GORMAN: Entirely new --

21 MR. WUELLNER: Entirely new for purposes of
22 doing the ROI calculation.

23 MR. GORMAN: You've -- you've done an ROI
24 versus building -- buying a new building versus
25 using what we've got on hand.

1 MR. WUELLNER: We did not do separately,
2 because we weren't really directed to do it again
3 because you'll do the ROI calculation on your new
4 build -- your original four at the time you go to

8 MR. GEORGE: What he's saying is the original
9 cost of the material for those four would still
10 have to go into the overall cost, you know, of the
11 building when we actually build them wherever
12 we're going to build them. So, that cost is going
13 to be there. Because it's not going to be, hey,
14 the building's free; it's sitting out there. No,
15 it's a cost on the books, kind of like inventory,
16 and when we erect them --

17 MR. GORMAN: Yeah.

18 MR. GEORGE: -- that cost goes with the --

19 MR. GORMAN: Right. I know. My point was,
20 in other words, you've got X cost in addition. In

21 other words, you're going to save some money, of
22 course, with owning the four partial material --
23 building materials, but you don't get the revenue
24 back. And so, there is a cost comparison, how
25 long it takes you to amortize your new heightened

1 cost of these large hangars.

2 In other words, the large hangars are going
3 to cost more because you haven't got any
4 materials. But you get more back. So, I mean, I
5 was just asking if he did an ROI on that.

6 MR. WUELLNER: I did -- I did not, because
7 they're really, for purposes of accounting in ROI,
8 they'd be entirely stand-alone projects. What --
9 what you're doing here would, you know --

10 MR. GORMAN: Not something I can go to war
11 on.

12 CHAIRMAN GREEN: Any other board discussion?

13 MR. GEORGE: I have a comment.

14 CHAIRMAN GREEN: Yes, sir.

15 MR. GEORGE: I want to compliment the design
16 of these three buildings together and saving walls
17 and everything. That's going to keep the
18 construction cost down. And what you're telling
19 me, that the -- just having the three together
20 helps with the wind load on hurricanes?

21 MR. WUELLNER: Well, there's -- there's a lot
22 of structural benefits to one structure versus
23 multiple structures.

24 MR. GORMAN: If you're going to go big, go as
25 big as possible.

1 MR. GEORGE: Well, another advantage is if
2 you get somebody that comes in that -- that meets
3 the criteria of the way we want to go, and they

7 could be opened up for a single tenant with three
8 bays, even, if it needed to be.

9 MR. GEORGE: Right.

4 9.E. - LITIGATION COST

5 MR. WUELLNER: Next item I have is actually

6 the item Mr. Gorman asked to have placed on there

7 related to litigation cost.

8 MR. GORMAN: No, I don't have a handout on

9 this. I -- I just wanted to -- unfortunately, I

10 wanted to make this one a bit public, as I have

11 been always curious, and I have never gotten an

12 answer for it. The litigation costs, what I

13 wanted answers for, I wanted estimates for, are

14 broken into two -- three separate inquiries.

15 The first inquiry is the cost paid in
16 percentage to -- to attorneys representing
17 homeowners. And please give a dollar figure
18 estimate. I know this is going to be an estimate,
19 hopefully without obscuring the issue, just the
20 estimate.

21 These costs add substantially to the cost of
22 real estate acquisition. This is going to be a
23 large sum of money. I'd just like that estimate.

24 Second, the cost we airport taxpayers will
25 pay the firm of Rogers & Towers to represent the

AIRPORT AUTHORITY REGULAR MEETING - JANUARY 19, 2005

95

1 airport in matters of eminent domain. I'd like a
2 total estimate of what those litigation costs are
3 going to be, what we're going to have to pay the
4 firm of Rogers & Towers.

5 And third, and last inquiry, starts with a
6 statement of facts followed by my opinions.

7 Request for the estimate of cost for the firm of
8 Rogers & Towers to represent the airport in
9 litigation to receive repayment for the large
10 terminal construction loss.

11 And my estimate is well over \$600,000 in real
12 loss. Including the fact that the facility was
13 not useful for over two years. It is a fact the
14 firm of Rogers & Towers failed to bond the hangar
15 structure called Phase II. Fact 2. We, the
16 airport, settled on \$200,000 for a \$600,000-plus
17 loss on the total structure. This is a total
18 loss. These are very round figures.

19 And the last is an opinion. My opinion is
20 the error of not bonding the second building so
21 severely compromised any leverage with the bonding
22 company that we received extremely poor and slow
23 performance in finishing the Phase I building,
24 Phase I being the terminal. After that, we could
25 not sue them.

AIRPORT AUTHORITY REGULAR MEETING - JANUARY 19, 2005

1 If we are actually going to run this airport
2 like a business, we need to start caring where the
3 money goes, where our tax dollars go.

4 My request: I am going to request, as a
5 future agenda item, after the litigation is done,
6 a performance review of the firm of Rogers &
7 Towers on approximately the one-year anniversary
8 of their contract renewal.

9 And after the law -- the law firm speaks, I
10 do have a closing statement.

11 CHAIRMAN GREEN: Okay. Any public comment?

12 (No public comment.)

13 CHAIRMAN GREEN: No public comment? Board
14 comment?

15 MR. GEORGE: I just have a point of
16 clarification. If we have action items, I would
17 expect to be -- have something that somebody wants
18 to take action on. If I have personal comments, I
19 want personal comments to be in the personal
20 comment session.

21 MR. GORMAN: The personal comments have to do

22 with the reason for the actual -- the actual
23 inquiry. And I volunteer my time to do this.
24 Part of why I'm here is to make these inquiries
25 so -- for the public good. And that's why --

1 MR. GEORGE: You have a point. You have a
2 point then. Okay.

3 CHAIRMAN GREEN: Any other board comment?

4 I have a comment, and I don't want to act as

6 attorney's fees and hourly rates, and I know
7 attorneys have high costs.

8 But I would like to ask our attorney, because
9 I have a different understanding, and I just want
10 to clarify it, not for my perspective, but from
11 our attorney's perspective, about the concern on
12 the failure to bond, which my understanding is
13 completely different than what Mr. Gorman said.

14 I don't believe Rogers, Towers had any

15 failure to bond. That was a contractual issue
16 that the engineering company and/or contractor
17 failed to do.

18 MR. BURNETT: You -- you -- for me to comment
19 too much related to --

20 CHAIRMAN GREEN: I understand.

21 MR. BURNETT: -- Earth Tech's liability and
22 the airport's litigation with Earth Tech --

23 CHAIRMAN GREEN: Just our allegations in our
24 petition.

25 MR. BURNETT: But as it would -- I would

1 rather not do that in a public meeting.

2 And one thing that I was going to suggest at
3 the end is when you get to setting the next
4 meetings -- or setting the meetings for the year
5 2005, excuse me, Gene Atwood and I talked on his
6 way out, and we would like to come back to you in
7 your March meeting with a shade meeting sometime

8 in March in order to update you more detailed
9 related to the Earth Tech litigation and discuss
10 strategy and -- and those sorts of things.

11 As far as Rogers, Towers having not bonded
12 the terminal construction -- or not required a
13 bond or failed to require a bond, that was not
14 within the scope of work for the Rogers, Towers
15 law firm.

16 Beyond that, I'd be happy to talk to you
17 about this issue. And, in fact, you're welcome to
18 contact George McClure, who was the actual
19 physical attorney at these meetings during that
20 time period to discuss it with him as well.

21 MR. GORMAN: All I can say is that -- is I
22 wanted just dollar figures. But in the normal --
23 the normal business of an attorney retained by an
24 airport authority would be to look after the
25 bonding of construction issues, period, and that

1 it is my information that Phase II was not bonded,
2 and that created a domino effect, period.

3 CHAIRMAN GREEN: Yeah, I --

4 MR. GORMAN: I just want figures right now --

6 MR. GORMAN: Dollar figures.

7 CHAIRMAN GREEN: I agree --

8 MR. GORMAN: That's all I'm interested in
9 now. We'll bring this -- this whole discussion up
10 later.

11 CHAIRMAN GREEN: I agree with our attorney.
12 I would suggest that this be calendared in a shade
13 meeting as far as attorney's fees, billable hours,
14 everything else which deals with the litigation.

15 So, if the board's okay with that, I'd -- I
16 would suggest that we do that in a shade meeting
17 before March, like our attorney suggested.

18 MR. BURNETT: Additionally, though, I would
19 just like to say that Mr. Gorman is, I'm sure,
20 welcome to review the -- the billing records and
21 invoices that the Airport Authority has here on

22 file related to our law firm and -- and the
23 invoices that -- that the Authority has received.

24 MR. GORMAN: So, we're saying at this point,
25 you have no figures that you can present.

1 MR. BURNETT: I have -- on the
2 condemnation -- well, I guess -- let me go ahead
3 and address part of this.
4 The attorney's fees on the condemnation, I
5 think to give you an accurate number or a -- or a
6 more detailed number, if you would let us get
7 through the February 1st hearing and let us come
8 to you in February, or maybe if -- or, if you can
9 wait until the March shade meeting, then we can
10 discuss, either prior to that, but that --
11 potentially, you and I could sit down and discuss
12 these matters, and if you felt it needed to be put
13 on as an agenda item or discussed more fully in a
14 meeting, we could certainly do that.

15 But I think on -- as far as the condemnation
16 case goes, we'll have a much better idea after
17 February the 1st.

18 On the Earth Tech litigation, we can give you
19 an estimate going forward, and I'll forward that
20 to you and maybe we can discuss it, and you can
21 let me know whether or not you think that needs to
22 go to the full attention of the board.

23 MR. GORMAN: I'm not surprised that the
24 attorneys ask for more time. I think they do that
25 a lot. That's certainly acceptable to me.

1 I have a closing statement if you're done. I
2 was just looking for figures.

3 CHAIRMAN GREEN: That's all right. Go ahead
4 and make your closing statement.

5 MR. GORMAN: Fine. In closing, my opinion --
6 this is just my opinion, but it's the opinion of
7 many other sources, it should have been the

8 bonding company's problem to sue Earth Tech for
9 incompetency, not ours, not the Airport
10 Authority's.

11 I'm asking the board to reflect on the fact
12 that we should not approve the payment of invoices
13 from Rogers & Towers for any litigation costs
14 concerning directly the -- the terminal debacle
15 and the losses incurred. Finished.

16 CHAIRMAN GREEN: Since this is, as I said,
17 board discussion, I just want to direct all our
18 board members, we are in litigation. There is an
19 attorney/client privilege in here. And I don't
20 want this board to compromise any of our
21 litigation or tactical skills. And I'll leave it
22 in our attorneys' discretion about what should be
23 an agenda item --

24 MR. GORMAN: That's fine.

25 CHAIRMAN GREEN: -- and what should not. So,

6 director's salary. That is something I have. And
7 as you know --

8 MR. COX: Just go to the next agenda item.

9 CHAIRMAN GREEN: Oh, I'm sorry.

10 MR. BRUNSON: Put it off two months.

11 MR. COX: Joking with you.

12 CHAIRMAN GREEN: I have the old agenda, and
13 they keep putting -- this has been going on for a
14 while. I think it was first presented --

15 MR. GEORGE: This is my item.

16 CHAIRMAN GREEN: Well, I have all the -- I
17 have all the reports.

18 MR. GEORGE: Okay.

19 CHAIRMAN GREEN: Okay. If you want to take
20 it, then I'll address what I have --

21 MR. GEORGE: All right.

22 CHAIRMAN GREEN: Go ahead.

23 MR. GEORGE: I tried to on a couple of slides
24 here kind of go back and summarize because, you
25 know, we -- we've talked about this, we've got

1 public comment, we've got board comment since
2 September. And I let my alligator mouth open up,
3 and so I wound up with the action item to -- to go
4 investigate it.

5 I've talked to a lot of airports, and -- and
6 a lot of airports and executive directors and
7 managers, and all of them are different. When you
8 start saying, okay, what about your ops? Well you
9 don't necessarily want to use ops; you want to use
10 this or you want to use whatever.

11 I've looked at studies and surveys. Naples
12 airport did a great survey of seven airports.
13 They do it every year to come up with their
14 compensation plan. We used the AAAE compensation
15 plan from 2000 and 2001.

16 And at the last board meeting, you asked me
17 to guarantee that I would have those numbers. As
18 late as this morning, we were on the phone with
19 Teakoe Coleman saying, "Teakoe, where are the
20 numbers?"

21 "Well, we're in the process of reclassifying,
22 you know, nonhub versus general aviation
23 reliever," and he's going to be another two or
24 three months before he gets some consensus on what
25 those numbers are.

1 When you talk to somebody about a number, a
2 number is not a number. It doesn't equal. You
3 can't say -- you know, you're always talking
4 apples and oranges. For instance, you've got
5 scope of work.

6 Some airports are actually owned by the
7 county, and the county pays an administrator, and
8 the administrator has nothing to do with budgets,

9 you know, with living up to those budgets, with
10 spending the money, with talking to the DOT, you
11 know, or anything.

12 Other ones are owned by cities, you know,
13 like the counties, and they have different methods
14 of doing this. And other ones are like ours, have
15 airport authorities.

16 A lot of the ones by the city and the county
17 are appointed, you know, by the politicians. And
18 sometimes they're just figureheads. And -- and it
19 seems to me that they're that way.

20 My conclusion is -- and we keep looking for a
21 crystal ball to say, oh, we got \$9,232, and that's
22 on the vertical shaft and on the horizontal shaft
23 is this; that's what's the salary. It ain't going
24 to happen.

25 The next slide tries to summarize everything

1 that I found that I think is appropriate. And I

2 emphasis that I, as an individual board member,
3 think is appropriate. Herlong is not on here. If
4 you wanted to do that, you know, whatever. If I
5 could get the slide, we could talk about it.

6 Excuse me.

7 MR. COX: Well, we could talk about your
8 salary.

9 MR. GEORGE: Right. But let me just present
10 some of the numbers and some of the things behind
11 it. This AAAE survey, from 2000 and 2001, they
12 had a percentage increase from 2000 to 2001. I
13 cut that back and tried to extrapolate it out to
14 2004. And airports of 100,000 ops were \$82-. A
15 hundred and fifty thousand ops were \$112-. And we
16 did 129,943 or some -- 130,000.

17 The Naples effort for those seven airports,
18 they were between \$93- and \$150-. One of them was
19 Tucson, Arizona. Not going to use that one.

20 But I found some interesting things. I got
21 Mr. Burnett to give me a -- not an analysis, but a
22 list of the St. Johns County government. The top

23 13 positions are \$81- to \$158,000. And I passed
24 that out at the last meeting, and if anybody else
25 wants to see it, you know, it goes all the way

1 down to director of recreations and parks.

2 We went to Jacksonville. Now, Jacksonville's
3 got four airports that they're controlling; JIA,
4 Craig, Cecil, and Herlong. They've got levels of
5 people up there.

6 Well, we asked them -- which one -- I'm
7 trying to figure out how many people it was.

8 MR. COX: Herlong is \$90,000?

9 MR. GEORGE: The top seven -- no. The top
10 seven positions in the Jacksonville Airport
11 Authority, the top seven people -- now, some of
12 them might be on the same level, but the top seven
13 people are \$90,000 to \$185- or, you know, plus.

14 Melbourne -- Melbourne's \$121-, and they have
15 ops of 161,000. I think Melbourne has got a

16 Grumman J-STAR program which we're transferring up
17 here. And they've got Harris Corporation, and
18 they've got a big flight school down there, also.
19 Vero Beach. Vero Beach is \$88,000, and I
20 didn't get much on ops or anything, you know, from
21 them. But they've got the Piper manufacturing
22 facility there, you know, kind of like we have
23 something here.
24 Titusville, I know the guy, Dave Edwards,
25 that was the old airport executive. And I called

1 him in Asheville. And he was saying, when he
2 left, he was making \$97,000, you know, down in
3 Titusville. And he went to Asheville and went to
4 Asheville at \$115,000.

5 There's one I didn't get on the chart. It's
6 Stuart. Stuart's executive director just got a
7 raise to \$103,000, and they have 110,000 ops.
8 Now, he said that our ops are different than

9 everybody else's because 62 1/2 percent of ours

10 are instrument --

11 MR. COX: Practice instrument.

12 MR. GEORGE: -- okay? I don't know if it's

13 practicing, you know, or not. But -- but the

14 point is, you know, that there's another one of

15 \$103- that's not up there.

16 If we take a look at ours, Mr. Wuellner's

17 present base salary is \$77,215. We've all talked

18 about that, and every time we talk about it, say,

19 well, what about the house?

20 Well, we went back and took the house at 800

21 bucks a month, and then factored it up for what he

22 would have to pay incomes tax if we didn't give

23 him that. So, if I adjust it up, it says he's

24 making \$90,000. That, to me, is on the low end of

25 all these others, whether they are applicable or

2 I put some suggested increase -- excuse me.

3 I put some percentage increases that you could see
4 down there, so that hopefully we can discuss it
5 and come to a conclusion.

8 that is the result of my analysis, Madam Chair.

9 CHAIRMAN GREEN: Public -- public comment?

10 MR. HICKOX: Very quickly. Pay the man,
11 please.

12 CHAIRMAN GREEN: Any other public comment?

13 MR. MARTINELLI: I second that.

14 CHAIRMAN GREEN: Mr. Martinelli? That was
15 Mr. Martinelli. Mike?

16 MR. GEORGE: I have one other thing to add,

23 to get accomplished, and who can do the job? I'm

8 to make an appropriate decision that way. And
9 like Mr. Martinelli said, and pay -- pay the man
10 and we'll just get on with it.

14 CHAIRMAN GREEN: Seeing none. Board comment?

15 Mr. Cox?

16 MR. COX: Yes. Please. That's a

17 tremendous --

18 CHAIRMAN GREEN: Job.

19 MR. COX: -- bunch of work there. It really
20 is. No, it's really good. It's good work.

21 And I'd like to add some comment, too. I've
22 been to airports all -- all over the United
23 States, all over. I've made presentations to
24 airports all over the United States, to -- to the
25 folks that run airports.

1 This airport has got the infrastructure here,
2 the support that's necessary here. It is -- we're
3 in a class all by ourself, literally all by
4 ourselves. Even though we don't have commercial

8 Category III airports that have commercial
9 airports. A Category III is an FAA

10 classification, Category III and II airports.

11 So, my feeling is -- and I -- and I highly

12 support the bottom number there that -- that Buzz

13 came up with, the 13 percent increase. And -- and

14 that would be my comment.

15 CHAIRMAN GREEN: Other board comment?

16 MR. BRUNSON: I have a comment. Being new, I

17 have spent a little time with Ed and been to the

18 board meetings. And I think we also should make

19 an attractive adjustment based on his commitment

20 and the board's commitment to get us off the tax

21 rolls. And I think that that -- with the

22 adjustment in the salary, it would further his

23 commitment to -- to help us do that.

24 MR. GEORGE: Would you possibly be in favor

25 in the future of having a bonus as we meet these

1 criteria, budget, you know, revenue and expense,

2 you know, budgeted at the --

3 MR. BRUNSON: All my business life --

7 but with quotas and projections of what gets done.

8 And very definitely I would be in favor of that.

9 CHAIRMAN GREEN: Mr. Gorman?

10 MR. GORMAN: Well, I always seem to be the

11 bad guy, odd man out. I'll just condense it by

12 saying that I think Mr. Wuellner's pay package

13 is -- is certainly commensurate with what he does

14 now.

15 He has other benefits at this airport that

16 you don't see, house maintenance, things like

17 that. And according to the house -- and adding

18 the house, he's got maintenance on the house.

19 He's got lots of good benes, and I don't think

20 that this -- just to sum it up, I don't think this

21 airport -- it has some unique qualities, but I

22 don't think it's so unique as to require such a

23 unique differential in pay.

24 Another -- the only caveat I really will

25 stick with is that we're still undergoing this

1 litigation I just talked about for a \$600,000

2 loss. It happened on his watch. And myself, I

3 would just table the thing. And then if

4 Mr. Wuellner gets the money, he gets our money

7 I mean, it just -- but it shows -- to me, it

8 seems a poor message to send to the taxpayers, to

9 approve a substantial raise at this time. I know

10 I'm the bad guy, but that's the way it is.

11 MR. GEORGE: I told you I'd give it to you.

12 CHAIRMAN GREEN: We're at board comment. I

13 do have a comment, as Mr. George tried to give me

14 his evaluation. We handed out evaluations I think

15 back in August or September, and I only received

16 three. For five members of the board -- and

17 Mr. Brunson is excused from this since he wasn't
18 on the board.

19 If this is such an important item, which it
20 is, I wish the board members who speak publicly
21 would fill out their evaluations privately so we
22 have something to work for. It's a complete
23 two-page evaluation, which -- and obviously I go
24 through and add up the numbers and just tell you
25 what our overall rating is, and this is what we've

1 done on boards in the past, so that the public has
2 some idea of what we as a board are working with.

3 And these numbers, I think, are kind of
4 skewed because I don't have everybody's input.

8 From what, the three that I had, the overall
9 rating was an 85, just so everybody knows. High

10 on the comment list was the ability to get funding
11 and to get matching funds, which I think is almost

15 the middle of heated litigation; you want to keep
16 somebody, keep happy and keep with you, who has
17 started the ship going and get those capital

22 everything that I've given you, I am in strong
23 favor of a salary increase. And I commend you for
24 all of that work, because that -- that's more than
25 we've ever had on the board before, that insight.

11 CHAIRMAN GREEN: And I really have no
12 comments other than thank you all for putting up

13 with me for two years and --

14 MR. GEORGE: Thank you.

15 MR. COX: Stellar job. A stellar job.

16 CHAIRMAN GREEN: Now I can make motions.

17 That's it for board members' comment.

18 11. - PUBLIC COMMENT & ADJOURNMENT

19 CHAIRMAN GREEN: Public comment? Yes, sir.

20 MR. SESONA: It's pretty well all said about

21 this salary increase and everything, but I'd like

22 to put a little more perspective into the value of

23 the rental of that home. And I guess we're about

24 as neighborly as any two people can get. I live

25 next door. And his house is far nicer than

1 anything that we own, and --

2 MR. WUELLNER: Or I own.

7 admired and envied by most of us. I guess we
