2	MS. BARRERA: I'd like to call the meeting of
3	the St. Augustine-St. Johns County Airport
4	Authority into session. And with that, we'll still
5	do the Pledge of Allegiance.
6	(Pledge of Allegiance).
7	MS. BARRERA: Thank you. We'd like to begin
8	our discussion on the millage rate by the
9	Authority. Do we have any discussion amongst the
10	board about the millage rate?
11	MR. BRUNSON: Has anything changed since the
12	tentative, Ed?
13	MR. WUELLNER: No, sir.
14	MR. BRUNSON: I mean the tentative
15	MR. WUELLNER: No, it's exactly the same.
16	MS. BARRERA: And we'll open it up for public
17	comment.
18	(None.)
19	MS. BARRERA: Hearing none, we'll move on to
20	the final adoption of the millage rate. Resolution
21	2014-04. Do we have a motion?
22	MR. BURNETT: If I could very quickly, I just
23	want to make sure that we overkill covering this.
24	I'd like to read the resolution into the record if
25	I might.

- 1 MR. WUELLNER: Before you do that, I just want
- 2 to make a note for the record also that it was
- advertised as required in The St. Augustine Record.
- 4 MR. BURNETT: Okay. This would be Resolution
- 5 Number 2014-04.
- 6 "A resolution of the St. Augustine-St. Johns
- 7 County Airport Authority of St. Johns County,
- 8 Florida, adopting the final -- excuse me, the final
- 9 levying of ad valorem taxes for Fiscal Year
- 10 2014-2015; providing for an effective date.
- Whereas, the St. Augustine-St. Johns County
- 12 Airport Authority of St. Johns County, Florida, on
- 13 September 15th, 2014, adopted for Fiscal Year
- 14 2014-2015 a final millage rate following a public
- hearing as required by Florida Statute 200.065; and
- Whereas, the St. Johns County -- excuse me,
- the St. Augustine-St. Johns County Airport
- Authority proposed a millage rate of 0.0000 and
- said rate does not exceed the rolled back rate.
- Now, therefore, be it resolved by the
- 21 St. Augustine-St. Johns County Airport Authority of
- St. Johns County, Florida, that the Fiscal Year
- 23 2014-2015 operating millage rate is 0.0000 mills
- 24 which does not exceed the rolled back rate.
- 25 This resolution shall take effect immediately

- 1 upon its adoption. Duly adopted at a public
- 2 hearing this 15th day of September, 2014."
- 3 That would be the proposed resolution.
- 4 MS. BARRERA: Do we have a motion?
- 5 MR. BRUNSON: I'll make a motion to adopt
- 6 2014-04 as read by attorney Doug Burnett.
- 7 MS. BARRERA: Do we have a second?
- 8 MR. CIRIELLO: I second.
- 9 MS. BARRERA: All in favor?
- 10 MR. BRUNSON: Aye.
- 11 MR. CIRIELLO: Aye.
- MS. BARRERA: Aye. None opposed. Motion
- passes. Moving on to the proposed budget, we have
- our proposed budget.
- MR. WUELLNER: Yes, a quick overview. The
- proposed budget for fiscal year 14-15 proposes
- operating revenues from fuel of \$126,586, leases at
- 18 \$3,210 -- excuse me, \$3,210,913, operating
- agreements totaling \$593,496, leaving a total
- 20 operating revenue projection of \$3,930,995, which
- statutorily would reduce 9 -- to 95 percent leaving
- \$3,734,445. Adding nonoperating revenues of
- reserves forward of \$5,108,275. We have no loans
- proposed for this fiscal year and grants totaling
- \$4,233,050. We -- we are representing a total

- 1 revenue projection for fiscal year 2014-15 of
- 2 \$13,075,771.
- 3 On the expense side, estimating personnel
- 4 expenditures of \$1,167,642, operating expenses of
- 5 \$1,508,805. We are projecting no debt service. We
- 6 are projecting reserves at the end of the fiscal
- 7 year at \$5,204,063 and capital expenditures during
- 8 the year of \$5,195,261 for a total expenditure
- 9 projection of \$13,075,771. And that includes the
- 10 representative -- we have a balanced budget based
- on those numbers and would recommend your approval.
- MS. BARRERA: Do we have any board discussion?
- MR. CIRIELLO: I wanted to ask a question.
- MR. WUELLNER: Go ahead.
- MR. CIRIELLO: Not on this, but where you gave
- the budget before the specific --
- MR. WUELLNER: Uh-huh.
- MR. CIRIELLO: -- you know I've been bugging
- 19 you about a special project. Is there any place in
- 20 the budget that if you so desired to do something
- 21 that would be beneficial to the airport as public
- relations on that item that I talked to you about,
- is there someplace in the budget that you can do
- 24 that?
- 25 MR. WUELLNER: Yes, sir.

1	MR. CIRIELLO: Okay.
2	MS. BARRERA: Do we have any further board
3	discussion?
4	(None.)
5	MS. BARRERA: Hearing none, we'll open up for
6	public comment.
7	(None.)
8	MS. BARRERA: Hearing no public comment, we'll
9	move on to the final adoption of the Resolution
10	2014-05. Mr. Burnett.

18	Whereas, the St. Augustine-St. Johns County

20	September 15th, 2014, adopted for Fiscal Year
21	2014-2015 a final budget following a public hearing
22	as required by Florida Statute 200.065; and
23	Whereas, the St. Augustine-St. Johns County
24	Airport Authority has prepared a budget for the

The annual budget estimates of revenues 8 and expenditures of the St. Augustine-St. Johns 9 County Airport Authority for the Fiscal Year 10 2014-2015, as considered and acted upon, under and 11 by the authority of the Laws of Florida, are hereby 12 ratified, approved and adopted, and the amounts of 13 money set forth therein are hereby appropriated. 14 2.
