VIAAIR ADDS MORE SEATS TO/FROM ST. AUGUSTINE, FL AND CHARLOTTE, NC Additional Connections to/from West Virginia Cities Also Added

(St. Augustine, FL) The Northeast Florida Regional Airport is pleased to announce the addition of jet service on ViaAir's nonstop service to Charlotte, North Carolina. The Embraer Regional Jet began flying the St. Augustine to Charlotte route on Sunday, October 2nd and has been well received by passengers.

The ERJ-145 is a premier regional jet aircraft that seats 50 passengers; up from the 30 seat EMB-120 turboprop. The larger aircraft offers passengers an all jet experience while maintaining the superior customer service passengers have come to expect from ViaAir.

Edward Wuellner, Northeast Florida Regional Airport Executive Director, notes the up-gauging from ViaAir is a testament to the community's support for the Airport and also shows the marketability of St. Augustine as a Florida destination to travelers coming in from both, North Carolina and West Virginia.
