8	This would be for geographic reference,
9	this is between $B-2$ and $6-24$ out on the airfield.
10	It's 90 percent funded by FAA. The remaining
11	10 percent is split between the Airport Authority
12	and Florida DOT, making the Authority's share
13	about about a hundred thousand dollars total.
14	We are asking that the grant be ratified, and
15	if you will do that first, I guess, and then deal
16	with the contract associated with that.
17	CHAIRMAN MAGUIRE: Okay. Bring it back to the
18	board for comments, discussion.

20	meeting that we had it coming, it was supposed to

24	the like number of \$1,852,045 (sic).

When we scoped this effort, Mr. Olson was -- I think felt very strongly that we needed to have more interactions with the -- with the board members. So we will have a couple of item -- a couple of things, a couple of types of meetings.

One, there will be briefings at the board meetings. So we will update you on the progress of the study. And then in addition to that, we will have three workshops with the board. And I'm sorry the contrast of the color is a little hard to see, but I'll walk you through the dates.

The first board workshop we would like to have is on October 27th. And I'll ask you if this is a good date. I mean, we're flexible within that week, so October 27th. And it would be a three-hour workshop to talk about -- it's a visioning workshop. We will talk about a mission, finding a mission, a vision, and some values for the airport.

So the first question I have is, would you rather have a -- an afternoon workshop -- an early

MR. LUCETTE: And then in addition to the board workshops, as I said, we will be coming to the board meetings to give you updates on the progress. And also there — there might be discussion items, so we'll bring those to you at that time. If we can go to the next slide.

So the way we had -- we have scheduled the different meetings, we want to be here and work with the strategic planning team and the board. We have meetings with the strategic planning team every two month currently scheduled, and then we'll have a meeting with the board every month in one form or another. We'll be meeting with the board either in the form of a workshop or in the form of a board meeting.

Something that we'll do between the first two workshops with the board, we'll have -- we'll have a couple of sessions of stakeholder engagement. So stakeholder engagement is something we want to do to get some input from the different stakeholders at the airport -- tenants, general aviation community -- but also meeting with some of the

1	local more general economic development community.
2	The way we schedule those stakeholder
3	meetings, the way we envision those stakeholder
4	meetings, we'll have three meetings with three
5	different groups. The topics will essentially be
6	the same, they'll be very similar in nature, to
7	solicit their input. And we'll have those
8	meetings right now we have that scheduled the
9	week of November 7th. That's almost exactly
10	between the first two board workshop. So that we
11	can bring the feedback from the stakeholders to the
12	second board workshop when we start talking about
13	initiatives.
14	That will be an in-person meeting. I mean,
15	those meetings will be in person, most likely in
16	this room, and we'll be working on scheduling those
17	meetings with the strategic planning team and the
18	airport. Any questions on that?
19	CHAIRMAN MAGUIRE: Any questions/comments from
20	the board? No?
21	MS. LUDLOW: Are you going to fill in the
22	dates or
23	MR. LUCETTE: Yes. And and I'll work with
24	the airport on the previous date when we do have
25	the dates, but it's going to be most likely over

1 two days that we'll have those three meetings.

2.4

And as I said, we'll compile the information — the feedback that we receive, we'll compile that in a way that can be presented to the board members when we come back at the second workshop, in order for you to have that information available to you when we start talking about initiatives. This is really to solicit input from the community at that point. And that will be in addition to the information that we prepare and bring to the board members.

As of now, we are targeting the March/April timeline to -- to bring a full draft of the strategic business plan to the board. So with a completion, a final completion in the month of May. So it's approximately nine month.

So, another item that I wanted to bring up today that we discussed with the strategic planning team last time was, you know, what are the goals of the strategic business plan? And I have noted here the goals that we brought to you before.

You know, providing guiding policies to the board and to help work with the airport management staff. Having a single long-term focus for the organization. Those are goals that we've talked

1	about before.	Ensuring that t	the airport	financial
2	sustainability	is viable long	term. And	if you go
3	one more, pleas	e.		

The -- the question that I have for the board is, are there additional goals that you would like to see within the strategic business plan? We want this to be a tool that's useful at the end of the day for you to -- to do your business as a board and to conduct your mission as a board member.

What do you think would be most useful for you if you had the strategic business plan as a tool to help you make decisions, to help you interact with the airport staff, to help you discuss problems internally?

And I just want to open this to you and understand, you know, a little more from your perspective what are your expectations. You know, what do you need to get in May 2023 for this study to be -- to be successful in your eyes?

CHAIRMAN MAGUIRE: Okay. That's an overhead question for us to think about.

MR. LUCETTE: You are welcome to think about it --

24 CHAIRMAN MAGUIRE: Yeah.

MR. LUCETTE: -- but I wasn't sure if there

was already some items that maybe you had in mind. 1 2. CHAIRMAN MAGUIRE: Anybody have an immediate 3 idea of what they would like to see? MS. GREEN: I think we need to throw it 5 around. I mean, there's all kinds of different ones out there. So --7 CHAIRMAN MAGUIRE: Yeah, I think we have to think on that one. 9 MS. GREEN: -- just think about it. 10 MR. LUCETTE: That's absolutely fine. CHAIRMAN MAGUIRE: Two good questions, though. 11 12 We need to look at --1.3 MR. LUCETTE: And some more questions for us 14 as well. 15 CHAIRMAN MAGUIRE: Okay. 16 MR. LUCETTE: But essentially it's really 17 about helping -- helping frame -- frame some of the 18 board members' policies for the airport and the 19 board members together. 20 CHAIRMAN MAGUIRE: Okay. 21 MR. LUCETTE: One item that we're going to be 22 doing before we meet with the stakeholder is we're

going to create an online survey.

So what we'd like to do before we meet with

the stakeholder groups on the week of November 7th

1	is start getting a little bit of information
2	regarding their businesses at the airport. What
3	are their needs? What changes are they seeing in
4	their business environment that we should consider
5	in the strategic business plan?

That will help us to gain some understanding about the topics that we should bring to the discussion at the working meetings. That survey, we intend on publishing the survey the second week of October, and we're going to leave it online for about two weeks and that should give us enough time to get the results, compile the results, and have that information ready for us to prepare for the stakeholder group meetings.

So, I don't know if there's anything that -any questions you have about how we reach out to
the tenants. Again, it's -- we're going to be
coordinating with the airport staff to get contact
information and to distribute those surveys to all
of those stakeholders.

CHAIRMAN MAGUIRE: What qualifies as a stakeholder?

MR. LUCETTE: Anyone who interacts with the airport in some -- some way.

25 CHAIRMAN MAGUIRE: How about those who don't

Ţ	have any interaction yet but hope to? Are they a
2	stakeholder or not?
3	MR. LUCETTE: As of as of now, we were
4	going to use the airport list for the information.
5	If you have any specific tenants or a stakeholder
6	that you would like us to survey
7	CHAIRMAN MAGUIRE: I don't
8	MR. LUCETTE: we can add them to the list.
9	CHAIRMAN MAGUIRE: but I know downtown
10	there are several business owners that over the
11	last couple of years have been thinking about
12	buying an airplane or whatever, just haven't gotten
13	around to it yet. So I was wondering would they be
14	a stakeholder or
15	MR. LUCETTE: As of now, we we weren't
16	going to include them but because we're going to
17	leverage the list of the common place that exists
18	at the airport. But again, it's an online survey,
19	so if somebody has feedback that they would like to
20	provide, it's easy for us to add them to the list.
21	CHAIRMAN MAGUIRE: Okay.
22	MS. GREEN: I'm sure they could respond and
23	say not a current tenant or not whatever, but have
24	an interest.

25 CHAIRMAN MAGUIRE: Yeah. I just hate to see

people turned away --1 2 MS. GREEN: Right. 3 CHAIRMAN MAGUIRE: -- because they don't have an airplane yet. 5 MR. LUCETTE: As long as we know who they are and we can reach out to them, I think that's something we could do. 7 CHAIRMAN MAGUIRE: Okay. All right. 8 MR. MIRGEAUX: Can we just broadcast it and 9 10 just open it up to the public, just the St. Johns County residents? 11 MR. LUCETTE: We can. It's -- we'll need to 12 13 know --14 MR. MIRGEAUX: And then like a question early in the survey, just be like, you know, identify 15 16 which stakeholder group you are and just you can, 17 you know, general public can be one of the groups. 18 MS. GREEN: Right. What your concern is. If it's for a hangar or if it's for commercial or if 19 20 it's for a restaurant or whatever it is. 21 MR. MIRGEAUX: Exactly. 2.2 CHAIRMAN MAGUIRE: Yeah. Recognizing the 23 airport's here for the entire county --2.4 MR. MIRGEAUX: Right. 25 CHAIRMAN MAGUIRE: -- okay? So the entire

- 1 county needs to be given the opportunity, if they
- 2 have an interest, to voice their opinion.
- 3 MR. LUCETTE: I think we can -- we can
- 4 absolutely include something like that.
- 5 CHAIRMAN MAGUIRE: Okay.
- 6 MR. LUCETTE: We are -- so, as part of the
- different stakeholder groups, we're going to be
- 8 including the general aviation community at large
- 9 here at the airport, the aeronautical businesses
- that are at the airport, and also a lot of external
- organizations that are in the community such as the
- 12 Chamber of Commerce, some economic development
- 13 groups. So we will get some of that external
- feedback. But again, I think if we -- we wanted to
- open it to the community at large, we could as
- 16 well.
- 17 MS. GREEN: We have some industrial people,
- 18 too, that are interested.
- 19 CHAIRMAN MAGUIRE: Industrial people.
- MR. LUCETTE: Yeah.
- MS. GREEN: Correct.
- 22 MR. OLSON: And the hotel owners --
- MS. GREEN: Correct. Right.
- MR. OLSON: -- that stage conferences and
- 25 seminars.

1	CHAIRMAN MAGUIRE: Yeah. Okay.
2	MR. OLSON: College.
3	MS. GREEN: Anything like that.
4	MR. LUCETTE: Good feedback.
5	And so, that as I said, that survey will go
6	out most likely the second week of October. So
7	we'll report on that next time, next time we
8	probably have the workshop.
9	CHAIRMAN MAGUIRE: Okay. Comments from
10	anyone?
11	(None.)
12	CHAIRMAN MAGUIRE: Is that it?
13	MR. LUCETTE: I've got one little more.
14	CHAIRMAN MAGUIRE: Good.
15	MR. LUCETTE: So, the next the next item is
16	the benchmarking. This is something that, again,
17	while going through the scoping, we were told that
18	there really was a desire to understand how some
19	other airports may approach some of their problems.
20	So we are we have we are starting to
21	look for tentative airports that would fit the
22	description of airports we would like to benchmark.
23	We are going to be reporting to the strategic
24	planning team a list of airports, probably a dozen
25	airports, that fit the criteria that we would like

1 to survey. And then we'll engage with a subset of
2 those airports.

We'll probably select three airports to reach out to and schedule a call with them most likely to discuss very specific items about their business that would be relevant for -- for the Authority.

And then in case some of those airports are not able to respond, we'll also have a few backup airports.

So that's a list of airports that will be running through the strategic planning team. And I'll talk with you, Ed, and Mr. Olson, if you want to circulate those names through the board members first to get approval, that's also something we could do. But that's — that's an effort that's about to start now. We're looking for airports right now that we could benchmark. Next slide.

So that -- that's about it for the presentation today. As I said, we just kicked it off. We're coordinating some data collection efforts. We do want to schedule those stakeholder meetings as soon as possible so that we can -- we can lock people's calendars.

So that's why I had those questions for you today on the schedule. We'll probably go ahead and

1	put in the calendar the first and the second
2	workshop with the board as well as start blocking
3	out times for the stakeholder group meetings the
4	week of November 7th.
5	The online survey, we started to work on this
6	as being prepared as a as a Word document
7	initially and then that will be transferred into an
8	online survey tool. And lastly, the benchmark, as
9	I mentioned, is ongoing.
10	With that, any any questions or comments?
11	CHAIRMAN MAGUIRE: Questions from the board?
12	(None.)
13	CHAIRMAN MAGUIRE: Thank you, very much.
14	MR. LUCETTE: Thank you.
15	CHAIRMAN MAGUIRE: Okay. I have a comment I
16	want to talk about the workshop. And y'all can add
17	or just
18	I've been in numerous workshops for 40 years,
19	and I was four years with the county, and I've been
20	on both sides of the workshop. I've been the
21	person out in the audience just listening to the
22	people up here talk and I'm itching to say
23	something, and I've been on the table doing a
24	workshop on the other side of the table.
25	The purpose of the workshop, and this is

1	something y'all have to we all have to come to
2	agreement on, the purpose of the workshop is for us
3	to talk. It's not for them to say, Wait a minute,
4	I object to what Robert's saying. It's up to us,
5	okay?
6	So my my my experience shows that
7	workshops that are limited to us work far better,
8	we get more done. Workshops that allow comments
9	from outside detract from the objective and it
10	limits the amount of work to be done because it
11	takes time. And if someone out here hears
12	something they don't like, they can make notes and
13	bring it up at the next meeting so it's not lost
14	forever.
15	But we have to think of how we want to conduct
16	the workshop, so and I won't bring it up right
17	now, but later we will. When's the first do we
18	have one more meeting before the next work
19	MR. WUELLNER: You do.
20	CHAIRMAN MAGUIRE: Think about how we want to
21	do that. Just us and staff or outside
22	interjection, okay? That's it for me, okay?
23	Administrative policy. Ed?
24	ADMINISTRATIVE POLICY - MEETING ROOM USE

MR. WUELLNER: Yeah. At -- at your request

and based on some some comments we have received
to date, we were looking to take a look at the
administrative it's actually a section of the
administrative policy of the airport at it relates
to the meeting room use, which is the room you're
in.

2.4

When the policy was originally drafted in 2009, there were basically three spaces that could be -- could be utilized. The board made a decision at some point to lease the -- what was Meeting Room A, which is the room next to us, to Passero. That sits under a lease now and is unavailable for public use as such.

This is Meeting Room B. There was a meeting room downstairs when the building was first built. Since that time, it's been incorporated into the downstair tenant's leasehold, including all the -- the little offices that were down there. So that space is also gone for purposes of continual rental or access.

That leaves you just this room. This room is about 35×46 in size, has some eventual fire code limits that of course are ascribed by a county when the building's built. We constructed a policy that we thought at the time kind of dealt with most

1 contingencies.

2.

As we got into of course the realm of COVID in the last couple of years, some of the dynamics of how we would make that available and the like dramatically changed because of the cost structure primarily of getting -- keeping -- getting and keeping this room in a condition that would be usable and limiting the -- of course the long-term liability of the airport as it related to the COVID impact.

We are really at a point now that the meeting room can be back in service for the most part. But there are some very real costs that came out of that kind of reared their head during the COVID impacts in terms of how much it really costs to clean and get this room set up and torn down and do all of those things.

When we look back at our usage over the years, by far, the amount of use that's going on is -- is very heavily shaded toward governmental when it's not an Airport Authority use.

So we have a lot of little uses such as CDDs, homeowner associations, entities that aren't really governmental but are kind of community oriented such as the Civic Round Table. The Coast Guard

Auxiliary has been a consistent user of this
building for whether it was the whole building
or this by that, I mean floor, not building.

2.2

The School District historically has used this significantly over the years for everything from group meetings and teacher orientations to one time they had an event called the Academy Awards, which is sort of their way of recognizing the business partners associated with all of the academic academies at all of the high schools across the county. They held that here one time.

We do occasionally get private sector uses, things like showers and weddings, graduations, retirements, even celebrations of life from time to time. Those kind of events. And we've even had a couple of attorneys approach us and use the space for seminars and symposiums and little gatherings like that. Those would typically be considered private sector uses or private uses of the -- of the facility.

The policy envisioned all of those different kinds of uses. The original board action on the policy kind of took rental off the table for governmental uses.

And there is some difficulty, while that's a

great deal of the use, even moving toward
collecting or charging for that space, the
economies or the vehicles available to collect from
those governmental or quasi-governmental agencies
makes it unlikely that we would be they would be
rented, that the space would be rented and used,
just because it's difficult for other units of
government to pay for space, notwithstanding.

We also made it available at no cost, as you recall, to kind of nonprofit kind of uses. Of significance were aviation uses. I think there are some groups that aren't really well defined by either category because the original public use or nonprofit kind of use was geared toward aviation as the original policy was written, but when you look at the preponderance of uses, they're really not aviation not-for-profit kind of uses that got the most use, it's nonaviation not-for-profits; i.e., the Civic Association -- or the Civic Round Table. I'm sorry, I keep calling it the Civic Association. Even Coast Guard Auxiliary, while it may or may not be considered governmental at the end of the day.

We put up a couple of items, I don't know if you've got another slide of it, but items that we felt within the policy that need a -- need a

1	look-over quick within and today's you know,
2	I'm not sure we get to a final policy today unless
3	you want to provide all that input today.

The idea was to give you an idea of what we think are perhaps deficiencies or things you want to talk about related to this policy and give us some feedback and we can draft, if you will, or redraft or edit the existing policy and get it to where everybody's happy and maybe adopt it in early October, if you want -- want those kind of wholesale changes in there.

I don't know what's going on with our air -through the air video today. It's just acting up
like crazy. But issues including the cost
structure, the real cost of using things.

Equipment use, the equipment in this building, just to add a little point to it, a great deal of our equipment is end of life. I mean, it's at 10 or more years old. And much of it's been used and well used, and most — most of it's not supporting today's technology, especially video and things like that that are being used in meetings.

The -- how we allow or disallow food and beverage to include alcoholic beverages in certain cases and the insurance that's currently in our

1	policy that's required for those events. The fee
2	structure for use of the facility, the setup and
3	teardown, cleanup, those kind of things. The
4	equipment use at this point, we do have little
5	charges for certain equipment. But as I said, some
6	of that's at end of life and will need to be
7	replaced. You may want to look at maybe not
3	providing that equipment as a as a real use.

Last is scheduling and the priorities associated with who gets what when. That was established in the policy, but it seems like there's some -- perhaps some interest in looking at those priorities and maybe reestablishing or giving us some additional direction in that.

So we see those as the primary items that you may want to look at. You may not want to change any of them. You may want to change just a few.

It's up to you. That's what this is about.

19 MR. OLSON: Okay. Well, I had a question.
20 Pre COVID --

MR. WUELLNER: Uh-huh.

MR. OLSON: -- was there a -- did you have a lot of situations where you had to -- people were trying to -- there was enough demand that you were needing to do a lot of work managing how you fit

entities into the use of the building or not? 1 2 MR. WUELLNER: Well, I think one of the things 3 that get underestimated is the amount of time that it really requires if we do the setup of the 5 building. Every group has a different idea of what they 7 need or want, whether it's, you know, tables 8 around, something like this or theater-type seating or stuff with -- for training, the setup's going to 9 be different and all requires significant staff 10 time to tear down --11 12 MR. OLSON: Yeah. 13 MR. WUELLNER: -- not only the previous use 14 but re-set up. Then lastly, of course is the -- you know, 15 16 getting the technology to function with -- it 17 requires almost somebody here when they -- the 18 group initially shows up to make sure that if 19 they're using our technology, we can be making it 20 to work. 21 Then there's the difference between cleaning 22 and sanitizing, which is kind of where the expense 23 and the time --2.4 MR. OLSON: Yeah.

MR. WUELLNER: -- related comes in.

We don't want 18 to compete with the hotel meeting market, I don't 19 think. 20 MS. GREEN: Weddings and --21 MR. OLSON: Yeah. 2.2 MR. WUELLNER: No. And maybe a little -- yes, 23 we do have an order of priority and that's 24 established in the policy and it's -- right now it's this. The official airport business, which

1	includes all types of Authority meetings and staff
2	uses is number one priority. So it would preempt
3	any other scheduling or any other meeting desires.
4	Then we've historically prioritized next
5	outside governmental uses. They tend to be the
6	least flexible and have the fewest options
7	available to them. That includes local, state, and
8	federal agencies that may request a use.
9	Third would be aviation groups, and these are
10	non not-for-profit organizations, whose primary
11	purpose is related to aviation.
12	And then the last would of course be private
13	meetings, groups, even extended at this point to
14	private businesses on the airport who wish to lease
15	this particular space. And that was a so they
16	would be in theory the lowest priority.
17	But frankly we have so few contact excuse
18	me, conflicts, that it's really not not an often
19	situation
20	MR. OLSON: Okay.

1	We we are starting to see at the county a
2	bit of a slowdown following the the red hot
3	market we've had for the last two years in building
4	and home sales. But during the height of COVID,
5	oddly enough, we were issuing around 6- or 700
6	permits building permits for single-family
7	homes, 5- to 600. One month, June of '21, we hit
3	800. But prior to COVID, we were averaging about
9	350.

We're back down to averaging for the last several months around 350. That's still, you know, a pretty strong market, but it's starting -- as you've seen around the country and around Florida, it's starting to sort of settle off a little bit, settle down and slow down. But it's certainly not stopped.

And I don't anticipate, frankly, from where I sit, any kind of extreme slowdown in

St. Johns County for better or worse due to we still remain apparently one of the -- the destinations for people not only from the northeast, but California, Texas, it's an amazing. Colorado. They're just loving us to death.

So with that said, a couple of highlights that you may have read or heard about in the last month

1	or two. We're going to we're going to probably
2	have a sort of a charrette, if you will, looking
3	at the what is the greater World Golf Village
4	area, now that the Hall of Fame is relocating.
5	They're not leaving next month. They're planning
6	on relocating to North Carolina probably in early
7	fall of next year, fall of '23.
8	But what I want to do as one commissioner, and

But what I want to do as one commissioner, and I'm going to bring this up with my fellow commissioners tomorrow, is that the residents and shop owners, businesses from that greater area around what is now World Golf Village -- which is the big circle, right?

And, you know, what -- how would you like to sort of re -- revisualize -- revitalize and have a vision for that whole area? Because the county is a player. We have about 31 acres that we own.

Some of it is under long-term lease to the Renaissance hotel and we have the conference center.

But I think it's an exciting opportunity, because if you think about it, World Golf Village was approved and then constructed in the late 90s, early 2000s. And think how many people, how many families have moved into that greater area that we

L	call World Golf Village where it's Mur whether
2	it's MuraBella or other communities around that
3	area that you know, what would those now current
1	residents like to see if the Hall of Fame not
5	if, but when it leaves. And I I'm totally open.
õ	I look at it like a blank screen, not a screen with

letters and numbers.

So I'm pretty excited about the opportunity, I think, to really revitalize what has been called World Golf Village. But I think we would like to come up with something that everyone would buy into and support. So we have time to work on that, but I would like to start the process after the first of the year, probably.

So, I want to give you, excuse me, a heads-up on another thing I'm going to mention tomorrow at the commission meeting. For those who follow local news, county news, I think all of you are very much aware that there is on the ballot November 8th a referendum asking the voters whether or not they would approve or not a one cent sales tax increase going from 6 1/2 to 7 1/2.

We'll just see how that plays out. It's either going to pass or fail. If it does pass, I'm going to go ahead and start the process suggesting

to my fellow commissioners tomorrow that although
the staff has come up with a recommendation they
did last spring on, one, how far we are behind in
our backlog of infrastructure and a list of capital
projects ranging from a long list of different
roads that need to be improved or built, parks,
libraries, fire stations, and a couple of other
items. But I really want to hear from the public
if this passes. I want -- I want community input
if it passes.

2.4

So -- but I want to go ahead now and ask my fellow commissioners to think about inviting citizens from around the county to submit applications to serve on a citizens advisory committee that would sort of scrub our staff work and hear from what that particular community, whether it's Ponte Vedra or Fruit Cove or Hastings or downtown St. Augustine, what do you think, what are you hearing from your residents, your local neighbors, of what the most pressing need is?

So I'm going to suggest tomorrow that we create that and -- and that type of advisory committee and invite everyone who wishes to apply for that. So anyone here that might be interested, anyone there that might be interested.

1	Because if we wait several months and wait
2	until after the referendum is voted on, and
3	assuming it does pass, I don't want to wait that
4	long. I want to go ahead and be ready to hear from
5	the citizens because our backlog is so great and
6	the needs are so great.
7	If you drive almost anywhere now in the
8	county, particularly on 210 or well, just pick a
9	road, 16, we we need to act sooner rather than
10	later. So I want to just touch on that, and then
11	I'll be happy to answer any questions you may have
12	this afternoon, Bruce.
