9	generating this information. Ed had, you know,
10	all of the information on overhead and they're
11	looking to see, you know, if we can go over the

19	got elected to this situation, we did so to serve
20	the public, and I don't I'm a bit disgusted
21	with the rest of the board members. If that makes
22	them mad, I can't help them. One of them, I
23	understand has had to go to the doctor, but that
24	leaves the rest of them.
25	And I think that to be responsible to the

1	taxpayers, we need to have a full board par
2	participation in this particular situation, as we
3	are spending millions of tax dollars. And we have
4	a very we have no one here but myself and Wayne
5	George. And so, although I have a few comments to
6	make, I don't see that, without both the positive
7	and negative input of the board, that we can do a
8	very good job of this, myself, my opinion.
9	CHAIRMAN GEORGE: Okay. My response to that
10	is that to go back over the last three years, some
11	of the biggest contention that we've had on the
12	board has obviously been the lack of understanding
13	of what the budget was and what went into those
14	numbers. And I consequently kind of agree with
15	you, Mr. Gorman.
16	Let me ask Mr. Wuellner or Mr. Burnett's
17	replacement. Is it is it within our rights to
18	postpone this meeting, reschedule it so we can
19	have more board members that are here?
20	Understanding that I've got a big impact on the

- 21 people that dropped their schedules to come out
- 22 here, and I apologize for that, but what's the
- 23 precedence?
- 24 MR. WUELLNER: Yeah, in principle, you can.
- 25 You can handle it one of two ways. You could

1	just you've called the meeting to order. You
2	could close it and say you've done what you
3	intended to do today and then reschedule another
4	meeting. Alternatively, you could table the
5	discussion to a date that you, you know, set up
6	and agree to at the next regular meeting. Net
7	effect is exactly the same thing.
8	CHAIRMAN GEORGE: Okay.
9	MR. WUELLNER: Wouldn't you agree?
10	MR. BATA: Off off the top of my head, I'm
11	not sure.
12	MR. WUELLNER: I don't think either one
13	you've got no statutory issue. It's a workshop.

14	It's not a public hearing or, you know, like an
15	advertisement, have-to-do-it-this-day kind of
16	thing. So I think you've got whatever flexibility
17	you believe, whatever you want.
18	CHAIRMAN GEORGE: I'd like to ask any public
19	comment that you know, anybody that would have
20	a major detrimental, you know, problem with us
21	postponing this meeting. Mr. Hickox?
22	MR. HICKOX: Oh, I have no dis Wayne
23	Hickox, 881 Queen Road.
24	I have no problem with you taking that step.
25	I think it's a wise one. I might point out to the

- 1 sitting members that probably the biggest single
- 2 complaint about the present board has been
- 3 attendance on the part of some of the -- some of
- 4 the members. Though I understand you've got
- 5 livings to make. That's not -- not meant that
- 6 way. But in a situation like this, I'm afraid

7	Mr. Gorman is right, y'all need to be here to work
8	on it. Thank you.
9	CHAIRMAN GEORGE: Okay. Mr. Ciriello?
10	MR. CIRIELLO: Joe Ciriello, 5318 Shore
11	Drive, St. Augustine.
12	Ed, what all you people are saying is
13	correct. But this is a workshop. You can't take
14	any legal action or do anything. So, not that I'm
15	a busy person, but I did take time to come out
16	here.
17	Let just Ed quickly run over the figures,
18	just so that we see what they are. I don't think
19	it would hurt. I would just assume sit here and
20	let him go through these figures and then you can
21	reschedule your meeting when actually make it
22	not a workshop so your people can put some input
23	in. But right now, it's just an information thing
24	and I don't see any harm in us sitting here
25	listening.

1	CHAIRMAN GEORGE: The biggest harm I have,
2	Mr. Ciriello, is that taking the time of
3	Mr. Gorman's and mine that we are going to be able
4	to vote on this at a later time, to have a nice
5	discussion and we come up with a nice set of
6	minutes that nobody's going to read the minutes
7	excuse me, I suspect that some of the other board
8	members won't read the minutes and they will lose
9	the benefit that we will achieve for one whole
10	year by going through the detail with us in here.
11	Can you to satisfy Mr. Ciriello, can you
12	give us just a quick overview of how you were
13	planning on running this meeting, because I know
14	that this is the first time that we've gone
15	through, you know, in a lot more detail the
16	definition of everything.
17	MR. WUELLNER: Sure. The as we've put the
18	meeting together, we intended to address a number
19	of things. In in a in addition, we're going
20	to provide you with a book with a lot of detail

- 21 that we won't necessarily cover in the meeting or
- 22 won't necessarily -- I'm not going to go by page
- by page and go through that.
- 24 But if there are questions about how
- 25 particular line items are developed in the budget

1	or even how we've got or the previous year's
2	information, where we stand this year, you know,
3	any of that detail, financial detail, you may want
4	to look at or consider all of that will be in that
5	book and we'll be able to refer to it and come
6	back to it as a particular line item or a
7	discussion comes up. Otherwise, we're following
8	kind of the same format.
9	I've developed a a single-year draft
10	budget, for lack of better terms. It takes what
11	we believe to be the what is the budgeted
12	line-by-line items, compared to where we are
13	year-to-date based on, this would be the end of

14	April as the as kind of the mark point, if you
15	will, in the year for seven months of the fiscal
16	year; our forecast of where we see the balance of
17	the current fiscal year ending up, which is the
18	blue column up there, if you're just kind of
19	reading it across with me. Then the other, the
20	last column on the right or column H, if you're
21	looking at the top, is the what we see as the
22	proposed budget needs moving into next year. So,
23	that that would represent next year's numbers.
24	Now, we've also developed I I kind of
25	expanded the sheet a little bit of it's off the

1	page here, but we can slide it over as c	liscussion

- 2 warrants later, but we compare the '05 and '06
- 3 budgets and get some idea of how those general
- 4 topics compare. And we've got that for all the
- 5 backup sheets, also, that you're looking at the
- 6 summary sheet currently.

7	Then we also have the ability to slide it
8	over here a little bit further and get some
9	additional data versus budget in current year
10	versus actual for based on the per the
11	per proposed, I should say the end-of-year
12	forecast number, budget number.
13	So it gives you some idea of how that how
14	we see the current year playing out, where we are
15	to date, what that implies for next year's
16	budgeting or things we may want to consider in
17	building next year's budget, or adjusting what
18	we've already put together. And it gives you some
19	basis for comparing this year versus last year
20	forecast versus existing this year also. And
21	that's available for every every one of the
22	backup sheets for personnel, for operating, for
23	capital, all of those kind of things.
24	The operating budget sheet also just to
25	give you a little more of a preview, also provides

1	an additional column out here on the right-hand
2	side that tries to identify just major anomalies,
3	where something has strayed dramatically in the
4	especially in the operating budget, why. Just
5	give you a couple of you know, of quick little
6	statements
7	CHAIRMAN GEORGE: Yeah.
8	MR. WUELLNER: of why something might be
9	and trigger some discussion of what whether it
10	was an anomaly or, you know, something that we can
11	expect to continue.
12	The next phase as I saw it was we took this
13	data, based on the forecast end of the year and
14	the proposed numbers that I've we've built in
15	at this point and we move into the forecast
16	document, which gives you an idea of how we see,
17	from a staff, that playing out in the toward
18	the goal of being off ad valorem tax rolls,
19	looking out again another ten years, seeing how
20	those how we how those numbers begin to
21	stack up and, you know, is that still a reality.

- 22 You know, preview it to the point where it still
- looks very good.
- 24 CHAIRMAN GEORGE: Yeah.
- 25 MR. WUELLNER: And again, you have the backup

1	sheets for that. For each of those general
2	general items you see toward the bottom,
3	they're includes the nonoperating revenues,
4	capital, those kind of things. Those are all
5	available with ten-year with forecast data,
6	also. So we'll have that ability, too.
7	The balance of the document we have prepared
8	for you includes one of the areas I think you
9	guys really have indicated you wanted to weigh in
10	a little more in is in the development of the
11	capital budget, which includes all everything
12	from equipment to cap individual construction
13	kind of projects, capital development projects.
14	We have some backup information where staff

15	individuals have based on their
16	responsibilities, have made requests in the
17	capital budget, and we have information as to how
18	that relates to a document that y'all may have
19	forgotten because some of you aren't or haven't
20	been on the board as long as the document's
21	existed and it's not something we talk about
22	frequently, was a previously adopted strategic
23	plan which kind of identified some goals and
24	objectives back in 2001.
25	It's a document that probably needs some

- 1 some revision over time here, especially since it
- 2 was developed, you know, six months prior to 9/11.
- 3 So, there are likely to be some additional
- 4 strategic goals that the organization may want to
- 5 write in there.
- 6 But basically all our capital projects and
- 7 capital equipment needs tie back to that strategic

8	plan, that strategic goal. If it's not something
9	that we've identified as of interest to the
10	Authority; i.e., not making a strategic plan goal,
11	then it's probably not made any consideration
12	within the budget and is not something that is
13	actively playing in the numbers.
14	But those individual projects are there. You
15	can select and delete and from that list, those
16	sheets, and it provides a little bit of backup
17	detail as to what we expect that item to cost,
18	what the operating costs might be associated with
19	it. Is there grant funds available? Those kind
20	of things are all summarized by by item.
21	CHAIRMAN GEORGE: Well, it sounds like that's
22	exactly what we had asked for, was to get into the
23	detail and make that detail available. It's a
24	shame that some of the three members are not here.
25	One's at the doctor in an emergency. One's at

1	the courts have kept her tied up with some things
2	that she's involved in. And
3	MR. WUELLNER: And the third had a pilot drop
4	off their flying roster today
5	CHAIRMAN GEORGE: So he had to
6	MR. WUELLNER: and he had to take the
7	charter. So he is the same problem.
8	CHAIRMAN GEORGE: One last comment and then
9	I'm going to adjourn the meeting.
10	MR. GORMAN: That's fine. Let me let me
11	modify disgusted to disappointed. And when can we
12	request breakouts, breakouts of specific line
13	items?
14	MR. WUELLNER: You will have that
15	MR. GORMAN: I don't have to do that in front
16	of the other board members.
17	MR. WUELLNER: Even within the half hour, we
18	should have you
19	CHAIRMAN GEORGE: Ed, can we get that
20	MR. WUELLNER: the entire documentation
21	that you could look at now if you want.
