Buildings Bid: Purchase and delivery of two (2) pre-engineered metal 12-Unit T-Hangar Buildings.

Doors Bid: Purchase and delivery of twenty-three (23) aircraft hangar doors for the two (2) Metal 12-Unit T-Hangar Buildings specified in the Buildings Bid (note that one unit has no hangar door).

Note: Bidders may submit a bid for both Buildings and Doors; for Buildings only; or for Doors only. Buildings & doors shall be delivered as specified in no more than 100 (one-hundred) calendar days from execution of the Agreement(s) between the Owner and Successful Bidder(s).
